 - d) Copy of GST Registration Certificate of the firm and PAN Card.
 - e) Copy of this tender notice along with its Annexure - A which mentions the technical specification, consignee details and terms and conditions duly

signed with seal of the firm in token of acceptance of terms and conditions.

2. The envelope titled "Financial bid for supplying indoor and outdoor furniture must contain all the documents.
 - a) Price bid in bidder's letter head containing price details as per Format - B (Should be submitted in separate sealed envelope along with the bid)
3. The technical evaluation Committee shall evaluate the technical proposal of the intending bidders.
4. The opening of the price bid shall be done only for those bids which are qualified technically.
5. The Price quoted shall be valid for a period of 1 year from the date of finalization of the tender. The total quantity as mentioned in II (Consignee Detail) may be altered at a later stage.
6. The order quantity shall be split amongst multiple technically qualified bidders as found appropriate by TDCCOL by matching L1 rate.
7. The total period of delivery for the ordered quantity shall be 30 days from the date of issuance of the Purchase Order. The purchase order shall be issued by TDCCOL in such a manner that selected bidder(s) will have to deliver the ordered quantity in a month.
8. The opening of the price bid shall be done only for those bids which are qualified technically.
9. The price quoted shall be inclusive of customs duty, packing, insurance, transportation (door delivery) and all other incidental charges EXCEPT GST. GST shall be applicable as per the prevailing rate.
10. No advance payment shall be made to the supplier. **100% payment shall be** made to the supplier against receipt of delivery of material and "The Stock Entry Certificate" at the consignee.
11. Incomplete or conditional tenders will not be entertained.
